



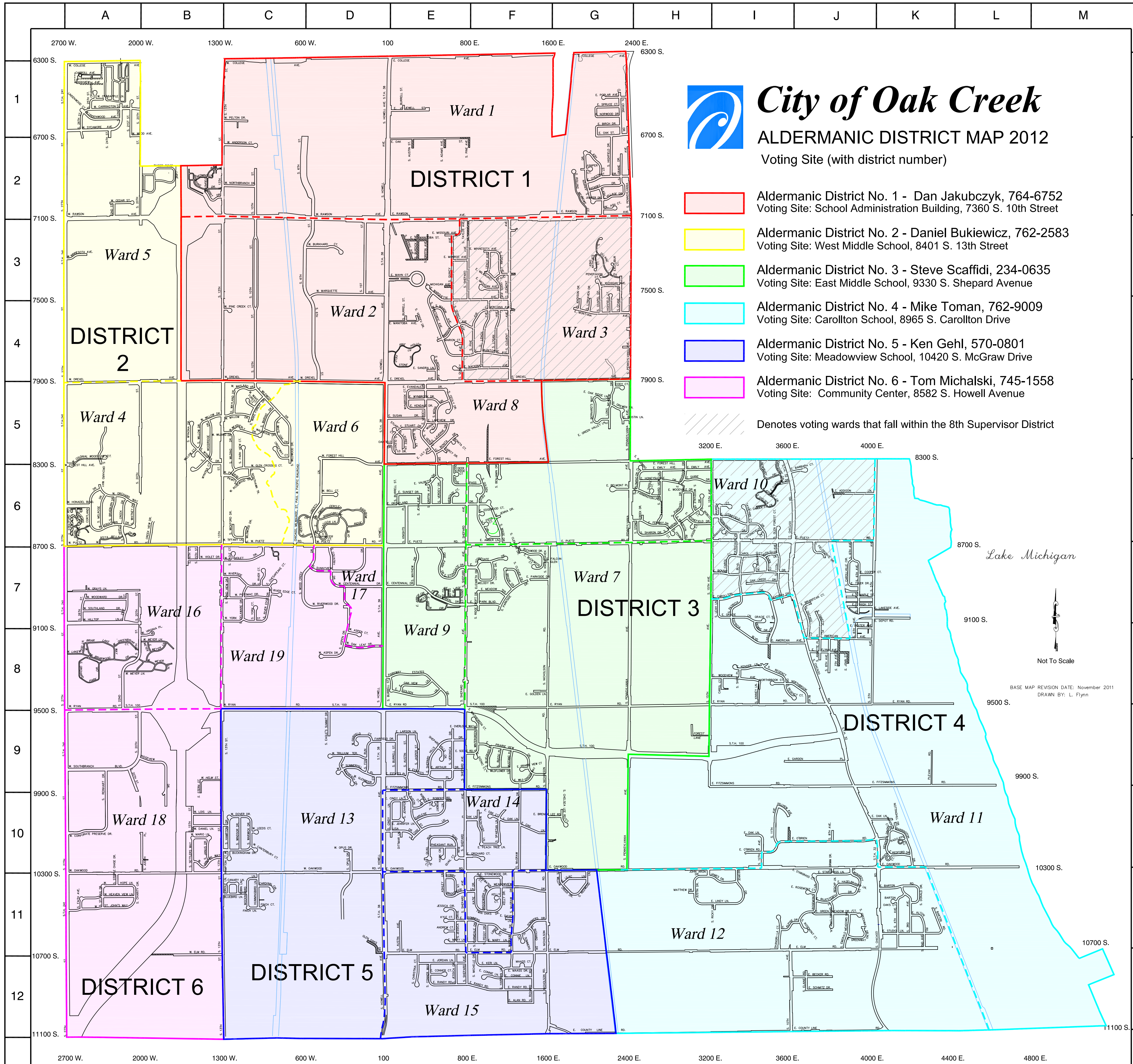

ALDERMANIC DISTRICT MAP 2012

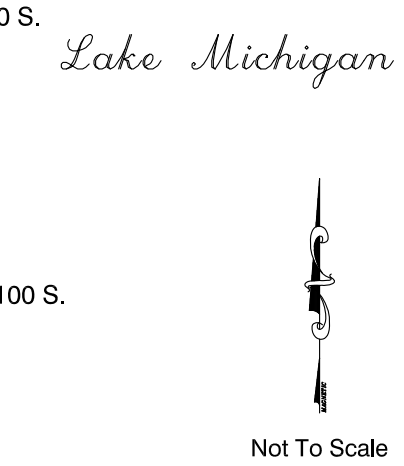
